Angela Dexter (AD) – SBM & Acting Clerk

Subject Lead Presentations:

History - Mrs Spall (SS) – Is a 2nd year ECT (Early Careers Teacher) and this is her first lead subject.

Long Term Plan & Skills progression shared – LTP on website and Skills on hub

Action plan -

- 1. History curriculum need to make a link between Britain and other civilisations i.e: what was happening in Britain at the same time as Greece!
- 2. SP wants to Increase her own knowledge of history curriculum.

KR - Do they cover previous times?

SS - More about the skills, enquire and look at different sources. Can link to geography.

SR - What are the links to British Values?

SS will look into more, example would be Greeks (study of democracy)

CB – How do you bring it to life for the children?

SS - Workshops available to support curriculum and try to link to the local area, Island and Hampshire. Victorian Toys, Buster Farm, Roman Villa etc

Next year - look at impact of action plan

English – Mrs Nordbruch (KN)

Action plan shared – On hub

Took over in September, spoke to SLT about strengths and baseline data.

- 1. Writing. (Teachers look at lower achievers)
- 2. Spelling KS2 (Phonics KS1) Take a more phonics-based approach in KS2.

New spelling scheme in place, consistency for teaching. Little and often and times to review gaps.

Children talking more about spelling and referring to KS1 phonics charts (accessible for KS2) Make activities hands on and active, play dough chalk, letter tiles. More importance on spelling.

Some learning journeys not shown in the end piece (story, report)

Teachers needed to strip back and focus on only a couple of skills.

Staff meeting held to review and encourage less but more in depth.

Learning journeys now more focused on objectives: ie Yr2 poetry, contractions and verbs - using correctly in final piece.

New text - focus on old learning journeys to revisit before moving on.

Reading Framework - Summer 2023 release

Revisiting expectations, class timetables have time to read for pleasure and for teachers to read to children.

Reviewed text to ensure balanced over the year. Time for teaching fluency from KS1 phonics onto Fluency for KS2. Particularly for those who do not read at home.

Reviewed techniques - paired reading etc

Heritage/Classic texts need to be looked at.

KR - Are they enjoying reading more?

KN - Pupil voice from years 3-6 - all positive. They could talk about reading in school and what a good reader is. More positive about being read to.

CB - Son has gone home and talked about reading and who paired with.

Book Event / Reading cafes / Displays / Weekly assembly to share story on values

More exposure the better.

SR - Is it too early to see impact in terms of data?

Spelling - March Data

Immediate - care over spelling

CB - Weekly spelling tests?

KN - Yes, cover it over the week. Friday is the test. Practice in school. Test in context. End of half term would be a test covering those learnt over the half-term.

CB- Is it incentivised?

KN - Yes - Stars awarded as per of scheme.
